

"SHARE YOUR TRACK" Call for Electronic Music Productions

The Escuela Superior Politécnica del Litoral (ESPOL), within the framework of the International Sound and Movement Festival, encourages the creation and dissemination of the performing and musical arts through masterclasses, conferences, transmission of productions, performances and contests. In this context, the call is opened for music producers from the 5 continents, who wish to share their work within the framework of the 8th edition of the Festival to be held from October 22 to 25.

CALL CLOSING DATE: September 20, 2020

Participants who send their tracks early, until September 13, will have the special benefit for free, of being part of the Sound Synthesis Workshop that will be dictated by PhD Ricardo del Farra from Concordia University - Canada, from 26 to 29 October with ZOOM.

1) WHO CAN PARTICIPATE?

Groups of students or record labels, collectives from sound arts and experimental video majors from educational institutions, including universities, music production academies or independent collectives of any nationality can participate in this space. For this edition the festival will receive new proposals, "TRACKS", of all kinds of electronic music (analog and digital productions) accompanied by a production of experimental video art.

2) HOW CAN THEY PARTICIPATE?

Each group of students or person must send until September 20 at 11:59 p.m. Ecuador, by wetransfer to the email dacampov@espol.edu.ec (Subject: Share your track), the following:

1. An unpublished composition, of any genre of digital or analog electronic music, soundscape or electro-acoustic composition.

Specification: The production must include a visual image throughout the track or, in another case, it can include an experimental video art. This is essential as it will be broadcast via YouTube.

The track must NOT include logos or names at the beginning. If they wish to include credits, they must be included at the end of the track.

Duration: The track must have a minimum duration of 2 minutes and a maximum of 10 minutes.

Format: The track must be sent in .mp4 format

- 2. Graphic piece that identifies its creation and logo of the participating collective or educational institution, in .ai format, that can be used by the festival for dissemination.

3) PROGRAMMING AND TRANSMISSION OF TRACKS

After the closing of the call, all the compositions received will be reviewed by our curators, who will check that the content is within the parameters of audiovisual and artistic quality, as well as that the content is suitable for all audiences. The festival reserves the right to transmit or not the proposals received as determined by the curators.

The proposals will be broadcast within the framework of the International Sound and Movement Festival from October 22 to 24. The schedules will be informed to the participants on October 5. The transmissions will be carried out through the ESPOL Cultural YouTube channel and will be taken off the air as soon as the transmission blocks are completed to safeguard the participants' material.

4) INCENTIVE TO THE 5 BEST PARTICIPATING PRODUCTIONS

Despite the fact that Share your Track is not competitive, ESPOL and the sponsors of the 8th International Sound and Movement Festival will give incentives to the 5 best productions received. These 5 productions will be determined by specialists from the sound arts and visual industry at a national and international level based on their musical content and sound design.

The sponsoring companies of the festival, Ableton, Genelec, Arturtia, LZX Industries, La Siesta del Fauno, Modular Moon, Sonoro, EASA will grant the 5 best productions the following incentives:

5) CONDITIONS OF PARTICIPATION.

Sending the registration form establishes that the participants:

- They claim to be the holders of the moral rights or authors of the musical content sent to the call. ESPOL is not responsible for claims or compensation that may arise in the event that participants infringe the rights of third parties.
- Accepts without the right to appeal, the decision of the festival curators.
- They have decided to comply with all the admissibility conditions established in the bases. The participant who does not comply with the established requirements is automatically excluded from this call without the right to any claim.
- They authorize ESPOL to use the audiovisual and sound content sent due to the call, and that which is registered during the days of the festival, without charging values for copyright, property or participation in the Festival. ESPOL may use said material for dissemination purposes without an expiration date.
- Each participant group or person will be in charge of editing their own material.
- They authorize ESPOL Cultural to project their track-production in Live Stream within the framework of the festival, which will be uploaded on our virtual platforms.
